RESOLUTION NO. 22

Surplus Vehicles

A RESOLUTION BY THE CITY COUNCIL OF THE CITY OF RIVERDALE DECLARING CERTAIN CITY PROPERTY, LISTED ON EXHIBIT A, TO BE SURPLUS PROPERTY AND TO PROVIDE FOR ITS PROPER DISPOSAL EITHER BY AUCTION OR OTHER METHODS PURSUANT TO THE CITY'S ORDINANCES AND STATE LAWS; AND FOR OTHER PURPOSES.

WHEREAS, City Code Section 2-87 governs the purchase, sale or surplus of property belonging to the city, not needed for public use or that may have become unsuited for public use; and

WHEREAS, pursuant to City Code Section 2-87, the method in which the purchase of city equipment, supplies, materials and services and sale of surplus city equipment and property is achieved shall be made in conformity with purchasing regulations established by the city manager and approved by the city council.

WHEREAS, various City Departments have provided a list of City surplus items to the City Manager, attached as **Exhibit "A"** to this resolution and incorporated by reference; and

WHEREAS, the City Manager has determined that it is in the best interest of the City to surplus such items, and has requested that such items become surplus and disposed of in the most appropriate manner.

NOW THEREFORE, be it resolved by the Mayor and Council of the City of Riverdale that the items listed on **Exhibit A**, attached to this resolution, be declared surplus and hereby gives authority to the City Manager to cause the items to be disposed of either by auction or in the most appropriate manner in accordance with City and State law.
