RESOLUTION NO. 26-11- 2020

WHEREAS, the City of Riverdale (hereinafter "City") is governed by the Mayor and Council; and

WHEREAS, the Mayor and Council observes certain state and federal holidays; and

WHEREAS, during such holidays, the City desires to show its appreciation to its employees; and

WHEREAS, it is the desire of the City to provide holiday pay to its employees for the year of 2020 by way of a separate payroll check as follows:

- Those employees designated as first-responders - \$1,000.00
- Those employees designated as regular full-time and not first-responders - \$500.00
- Those employees designated as regular part-time employees and not first-responders - \$250.00

WHEREAS, the City Manager is authorized to distribute the above-mentioned holiday pay for the year of 2020 and the FY2021 budget shall be amended to accommodate these payments; and

BE IT HEREBY RESOLVED, by a majority vote of the Mayor and Council of the City of Riverdale that the City Manager is authorized to issue holiday pay in the aforementioned amounts and the FY2021 budget shall be amended to accommodate said payments.
